

A Public Hearing was conducted on December 28, 2015 at 7:00 p.m. at the Wright Town Hall in Wright, Wyoming. The following were present for the public hearing: Mayor Ralph Kingan, Councilman Danny Preston, Councilman Nelson Litaba, Councilman Glenn Holt, and Clerk/Treasurer, Barbara Craig. Absent Councilwoman Lori Gilbertson.

The purpose of the public hearing was to hear public input for the Liquor License Renewals for 2016 for the following Liquor License holders: Wright 1, LLC. dba Open Range Steakhouse, Pridgeon, Inc. dba Hank's Lounge, The Nail, LLC dba The Nail, KR Golf, LLC dba Hay Creek Golf Course. With no comments from the public, the public hearing was closed at 7:05 p.m.

Gene Hanson (Drama Club) presented to the Council the problems with the lighting at the Wright Community Center, Mayor Kingan requested Building Official Lyle Murdock check into the matter and find out what is going on with the lights. Councilman Holt moved to approve the Retail Liquor License Renewal for the 2016 year for Wright 1 LLC dba Open Range Steakhouse. Councilman Preston seconded the motion, motion carried.

Councilman Preston moved to approve the Retail Liquor License Renewal for the 2016 year for KR Golf, LLC dba Hay Creek Golf Course contingent on lease agreement being extended to 2/6/2017. Councilman Litaba seconded the motion, motion carried.

Councilman Holt moved to approve the Retail Liquor License Renewal for the 2016 year for Pridgeon, Inc. dba Hank's Lounge. Councilman Litaba seconded the motion, motion carried.

APPOINTMENTS: Mayor Kingan appointed Councilman Glenn Holt as the Mayor Pro-Tem for a 6 month period, ending in June 2016. Councilman Glenn Holt was appointed the voting delegate for the 2016 WAM Winter Workshop Business Meeting, which will be held in Cheyenne on February 17, 2016 at 4:00 pm.
