At 7:00 P.M on August 26, 2019 a public hearing was held to hear public input on Ordinance 2019-09 an Ordinance prohibiting the use of Compression Brakes and providing for a penalty and effective date. Phil Worman, owner of Pullmax Inc. commented on the speed limit and where he thought it should be placed along with the Compression Brake signs and how it would be most effective for the Truck Drivers. Pete Johnson commented on the noise level and disturbance that the trucks cause when they use their Compression Brakes on HWY 387, with no further comments Mayor Kingan closed the Public Hearing at 7:09 P.M.
