Councilman Schrader made a motion to approve Resolution 2021-05 A Resolution of the Town of Wright announcing the Town of Wright's intent to expend funds for the Prospector Road Rehabilitation Project (paving) in the amount of \$750,565.21 this amount will include construction and engineering services Councilman Phipps seconded the motion.
