At 7:00 p.m. Monday, June 28, 2021, Mayor Ralph Kingan led the Pledge of Allegiance and called the regular Town Council meeting to order with the following being present: Mayor Ralph Kingan, Councilman Doug Schrader, Councilman Justin Robb, Councilman Joel Morgan, and Clerk/Treasurer Barb Craig. Absent Councilman Mike Phipps, **CONSENT AGENDA:** Councilman Robb made a motion to approve the Consent Agenda. Items approved under the Consent Agenda include the regular meeting minutes conducted on June 14, 2021. Approval of Vouchers in the amount of \$294,849.59 including payroll. Approval of the Consent Agenda for the meeting held on June 28, 2021. Councilman Morgan seconded the motion. Motion carried with all Ayes. **REPORTS** Chris Roemmich presented the Public Works report. Jean Kingan representing the Silver Sage Senior Center Board presented a letter of recognition for the outstanding efforts of Heather Nichols and David Heimdale for their outstanding service to the community and their outstanding meals that they prepare for the Senior Center, they worked through the Covid-19 pandemic to make sure that the Seniors could continue to have meals prepared and delivered daily. Ms. Kingan also presented the Silver Sage Senior Center report, she introduced the New Board Members, and gave an update on some of the services that the Senior Center will be providing and the fund raisers for the coming year. Campbell County Fire Department Chief Fox presented to the Council a proposal to update and adopt the International Fire Code to the 2021 Codes. The Town of Wright will be working with the Campbell County Planning Department to adopt the new codes. The WPAC report was presented by Robby Gallob. **Discussion:** Mark Hines from DOWL was present to answer any questions or concerns that the Council may have for the Bike Path Project Grant. He congratulated the new members of the board and thanked them for their service. **CONFLICT CLAIMS:** None. **CITIZEN COMMENTS:** Robby Gallob from WPAC presented to Mia Vrooman a check in the amount of \$50.00 for winning the Logo contest sponsored by the WPAC. **WRITTEN COMMENTS:** None. **APPOINTMENTS:** None. **OLD BUSINESS:** None. **NEW BUSINESS:** Councilman Schrader made a motion to approve Resolution 2021-07 A Resolution of the Town of Wright Authorizing the Town of Wright to proceed with the Annexation of Property owned by Wright Water and Sewer and certifying that all applications are true and complete, Councilman Morgan seconded the motion. Motion carried with all Ayes. The motion to approve Resolution 2021-09 A resolution of the Town of Wright Authorizing the submission of an application to apply for Federal Funding through the Transportation Alternative Program administered by the Wyoming Department of Transportation for the Town of Wright for the purpose of the Wright Bike Pathway Project. The request for approval was defeated by the lack of a motion. The motion to approve Resolution 2021-10 A Resolution of the Town of Wright providing for the appropriation surplus funds and transfer of unencumbered and unexpended appropriation from FY 2021-2022 for the adopted budget which would increase the revenue and the expenditures for the purpose of the Wright Bike Path Project, was defeated by the lack of a motion. Councilman Schrader made a motion to approve Resolution 2021-11 A Resolution of the Town of Wright adopting the updated EEOC Plan-Title V1 to ensure the public's confidence in the integrity of the Mayor, Council and Employees of the Town of Wright to reaffirm its policy to provide all individuals the opportunity to participate in Federal Financial assisted programs and to provide guidance to its officers and employees regarding that "no person shall, on the grounds of race, color or national origin be excluded from participation or denied benefits or be subjected to discrimination under any federal financial program or activity, Councilman Robb seconded the motion. Motion carried with all Ayes. Councilman Robb made a motion to approve the MOU (the Wright Inspection Services Agreement) between the Campbell County Planning, The GIS Mapping Department, and the Town of Wright for the Fiscal Year 2021-2022 in the amount of \$37,138.00, Councilman Morgan seconded the motion. Motion carried with all Ayes. Councilman Schrader made a motion to approve the Liability Insurance for the Town of Wright for the Fiscal Year 2021-2022 from Travelers Insurance (Burns Insurance) in the amount of 55,908.00, Councilman Morgan seconded the motion. Motion carried with all Ayes. **ANNOUNCEMENTS:** The Wright Town Hall and all facilities will be closed Monday July 5, 2021, to celebrate the 4th of July Holiday. The next Town Council meeting will be held on Monday July 12, 2021, at 7:00 pm at the Wright Town Hall Council Chambers. **ADJOURN:** With no further business Mayor Kingan adjourned the regular Town Council meeting at 7:35 P.M.
