At 7:00 p.m. Monday, July 26, 2021, Mayor Ralph Kingan led the Pledge of Allegiance and called the regular Town Council meeting to order with the following being present: Mayor Ralph Kingan, Councilman Doug Schrader, Councilman Joel Morgan, Councilman Justin Robb. and Clerk/Treasurer Barbara Craig. Absent Councilman Michael Phipps **CONSENT AGENDA:** Councilman Schrader made a motion to approve the Consent Agenda. Items approved under the Consent Agenda include the regular meeting minutes conducted on July 12, 2021. Approval of Vouchers in the amount of \$587,346.24 including payroll. Councilman Robb made a motion to approve Sony Yazzie being the representative for the Town of Wright for the Ladies Coal Tournament and the Town to pay for the advertisement for the Town, Councilman Schrader seconded the motion.
