A RESOLUTION AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR FEDERAL FUNDING ADMINISTERED THROUGH WYOMING STATE LANDS INVESTMENT BOARD FROM THE WYOMING WATER AND SEWER ARPA FUNDS GRANT PROGRAM FOR THE TOWN OF WRIGHT FOR THE PURPOSE OF THE FUTURE HOUSING DEVELOPMENT ON PROPERTY OWNED BY THE TOWN OF WRIGHT LOCATED AROUND THE HAYCREEK GOLF COURSE.

WITNESSETH

**WHEREAS**, the Governing Body for the TOWN OF WRIGHT desires to participate in the Wyoming Water and Sewer ARPA fund grant to assist in funding this project and,

**WHEREAS**, the Governing Body of the TOWN OF WRIGHT recognizes the need for the project and.

**WHEREAS**, State Land Investment Board requires that federal funding criteria be met, and the TOWN of WRIGHT agrees to ensure satisfaction of all requirements and,

**WHEREAS**, The Town of Wright acknowledges that if funded, the sewer project shall be completed prior to when grant funding is to be spent,

**WHEREAS**, the governing body for the Town of Wright agrees to set aside a minimum of 16% for the matching estimated cost of project and shall be implemented as a line item in its budget for the required amount of the local match.

**WHEREAS**, the governing body for the Town of Wright acknowledges that if funded the funds are on a reimbursement basis and all invoices must be 100% paid by the Town of Wright prior to reimbursement through SLIB. The Town of Wright acknowledges that failure to comply with this requirement may result in cancellation of the award and repayment by the Town of Wright of all funds reimbursed, and,

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY** for the Town of Wright that a funding application be submitted to the State Land Investment Board-ARPA Water and Sewer Grant Program for consideration to assist in funding for the Town of Wright project.

**BE IT FURTHER RESOLVED** that Ralph Kingan, Mayor, Barbara Craig, Clerk/Treasurer and HDR Engineering, Town of Wright' Engineers are designated as the authorized representatives of the TOWN OF WRIGHT to act on behalf of the Governing Body on all matters relating to this project.
