Anyone wishing to review the formally adopted and approved minutes should make their request directly to the Wright Town Hall, and not rely on these published draft minutes.* A Public Hearing was held to hear public input regarding the adoption of Ordinance 2017-04 an Ordinance of the Town of Wright, Wyoming amending Ordinance 2016-01 for providing for the Annual Appropriations for the Fiscal Year beginning July 1, 2016 to June 30, 2017 and Ordinance 2017-05 *An Ordinance of the Town of Wright, Wyoming Amending Ordinance 2001-16 Section 1 providing for regular public meetings of the Wright Town Council, and Chapter 6 Section 1-6-1 of the Town Code pursuant to Wyoming Statutes section 15-1-105 does hereby announce that the Wright Town Council Meetings shall be changed from 7:30 pm to 7:00 pm on the second and fourth Monday of every month.* With no comments from the public the Public Hearing was closed at 7:03 pm. Mayor Pro-Tem Danny Preston led the Pledge of Allegiance and called the regular Town Council meeting to order at 7:03 p.m. with the following being present: Councilman Glenn Holt, Councilman Nelson Litaba, Councilman Doug Schrader, Mayor Pro-Tem Danny Preston and Clerk/Treasurer Barbara Craig.
