Anyone wishing to review the formally adopted and approved minutes should make their request directly to the Wright Town Hall, and not rely on these published draft minutes.* A Public Hearing was held at 7:00 p.m. for the purpose to hear public comments on Ordinance 2017-08 an Ordinance of the Town of Wright, Wyoming Amending Sections 3-1-3 and 3-1-5 of the Town Code, Changing the Operating Hours of Bars and Presence of underage Persons in the Licensed Building, and providing for an Effective Date. Comments were heard from members of the Community supporting the ordinance that would allow the Liquor License Holders to have the established hours of 6:00 am to 2:00 am seven days a week which would also change the hours on Sunday's to include those hours. Hank Pridgeon owner of Hanks Road Side Bar and Grill requested that the Packaged Liquor Drive-up and Liquor Store would be able to sell packaged Liquor 24 hours a day seven days a week, this would increase revenue and would also enable his employees to pick-up extra shifts. At 7:10 pm Mayor Ralph Kingan led the Pledge of Allegiance and called the regular Town Council meeting to order with the following being present: Mayor Ralph Kingan, Councilman Glenn Holt, Councilman Danny Preston, Councilman Nelson Litaba, Councilman Doug Schrader, and Clerk/Treasurer Barbara Craig. **CONSENT AGENDA:** Councilman Litaba moved to approve the Consent Agenda.
